Devastating fire engulfs grocery store and mosque in Park Extension

No injuries reported in early morning blaze on Jean-Talon Street

A three-alarm fire wreaked havoc in Park Extension early Friday December 15th morning, engulfing a popular grocery store and impacting a mosque located on the second floor of the building. The blaze, which started in the basement, led to the evacuation of nearby residences but, fortunately, resulted in no injuries.

The incident began when employees at BK Marché, who were starting their early shift, heard a startling explosion followed by the sight of smoke rapidly filling the building. The grocery store, a staple in the community with over 50 employees, found itself at the center of a crisis. Approximately 90 firefighters rushed to the scene at the corner of Jean Talon Street and Bloomfield Avenue just after 6 a.m., battling the flames that originated in the basement. Their swift action was crucial in preventing further damage and ensuring the safety of those in the vicinity.

The event drew several people from the area, who gathered near the site, offering support and solidarity to the store's owner and employees affected by the disaster. This communal response highlighted the close-knit nature of the Park Extension community. Jean Talon Street was closed to traffic between L'Acadie Boulevard and Querbes Avenue throughout the morning, causing significant disruptions. As of now, the fire department continues its investigation into the cause of the fire, seeking to understand the origins of this unexpected tragedy.



Number of patients who died while waiting for medical care hits 5-year high

Over 17,000 patients died before they could be treated with surgery or diagnostic scans, a new report says

The number of patients who have died in Canada while on a waiting list for medical care is at a five-year high, according to a new report.

At least 17,032 patients died while awaiting surgery or diagnostic scans in the study period from April 1, 2022, to March 31, 2023, says the SecondStreet.org report.

"The data consists of cases where patients died waiting for procedures that could have potentially saved their lives (e.g. a heart operation) and procedures that could have improved their quality of life (e.g. hip operation)," the Reginabased public policy think tank said in a Dec. 6 news release.

The report is based on data obtained through freedom-of-information requests filed with government health-care bodies nationwide, including provincial health departments, health regions, and hospitals.

Data from those that provided figures for each of the past five years shows a 64 percent increase in annual surgical waiting list deaths since 2018, the report said.

In total, over 58,600 patients died while waiting for care since April 2018.

The report said the data it contains is underreported, as some health-care bodies did not track that data in the past or only tracked partial information. However, it said SecondStreet.org was able to obtain "at least partial data from 12 health bodies, altogether covering more than 73% of the population's health care."

"Patients died after waiting anywhere from less than a week to nearly 11 years," the report said. SecondStreet.org president and report author Colin Craig described the situation as "deplorable."

"More money won't solve the problem. Governments have tried that for 30 years. Only meaningful health reform will reduce patient suffering," he said in the news release.

According to the report, per capita government health-care spending has risen from \$1,714 to

\$5,607 since 1992, nearly double the inflation rate. Mr. Craig said more needs to be done, "At the very least, governments need to do a better job of tracking this problem and assessing just how many patients died because they had to wait too long for surgery."

Recommendations

The report suggested that governments consider partnering with the private sector to improve patient outcomes, where the cost would be covered by government, something Saskatchewan has been doing for over a decade.

Another policy option is to offer more healthcare choices.

"Instead of forcing these patients to decide either to wait for the provincial government to provide a particular health procedure or to leave their province (or country) for care somewhere else, the government could keep the public health care system, but allow non-government clinics in Canada to provide the same procedures."

Following the EU system is another option, where patients can travel to other EU countries for care, pay for the procedure, and then be reimbursed by their home government.

"Reimbursements cover up to the amount their government would have spent to provide the surgery locally," the report said.

October 2023 public opinion research commissioned by SecondStreet.org found that 74 percent of Canadians support the EU policy.

Another option is reforming the way hospitals are funded to an activity-based model, where they are paid based on services provided to patients instead of annual cheques that cover nearly everything.

This means "patients are no longer thought of as people 'to have to help' but rather as customers that should be welcomed as they represent additional funding," said the report. "This approach incentivizes output as every patient that receives a surgery or other procedure, results in more funding for the hospital."

Polls, Politics and Power Dictate Policies

I suppose we should not be surprised that our federal government tolerates, perhaps condones scandalous intrusions in the life of Canadian citizens in Ouébec. After all, most would agree this is a lame and limp bunch of leaders who feel quite comfortable with the Québec government's legal seizure of computers and cell phones in our English universities. And now imposing a French language requirement on visiting English university students. Most in our community are convinced it's an attempt to destroy the English infrastructure in the province. The Feds are busy calling for, well let's see, first, the Israeli right to defend itself, then a ceasefire in the Middle East. That's exactly what a recent Leger poll says Canadians are demanding from our federal leaders. Ontario, Québec and BC take the lead, with 8 people dying in BC alone, every day. There have been close to 13 thousand since 2016. It has prompted BC's chief coroner Lisa Lapointe to resign "frustrated and disappointed."

She began providing monthly updates, (similar to Covid deaths) to bring awareness to the situation but never got the response or commitment from governments for help.

Ask organizers of Christmas dinners for the underprivileged and homeless. Attendance is reportedly down from several years ago because of fentanyl deaths. The figures have been propped up by a record wave of people losing their homes and unable to afford living. It's not a vote-getter for politicians, so we are just letting Canadians die on the streets or in their beds, if they have one.

Montreal clamps down: major overhaul in spending on dining, bonuses, and executive perks

In a major policy shift, the City of Montreal, including the borough of Park-Extension, is poised to transform its financial management approach. New regulations targeting restaurant expenses, alcohol consumption, and executive bonuses are set to be implemented city-wide from next month. This comprehensive reform signals the end of discretionary executive spending and the practice of awarding bonuses.

Prompted by the excessive spending scan-

dals uncovered by the Bureau of Investigation this fall, these changes aim to bring a new era of fiscal responsibility across all boroughs, reflecting the community-focused ethos of areas like Park-Extension. Serge Lamontagne, the general director, unveiled these significant reforms during the latest executive committee meeting, setting a precedent for a more accountable and transparent governance structure in Montreal.

End of discretionary expenses

Beginning January, city executives will lose their annual "functional expenses" budget, which previously amounted to several thou-



sand dollars. This fund was primarily allocated for employee recognition and engagement activities, such as Christmas or farewell parties. However, these events are not expected to be completely scrapped. Instead, funds will now be distributed per unit, based on employee numbers, allowing employee committees to oversee their management.

The abolished discretionary fund was previously criticized for its lack of oversight, leading to questionable expenses. A notable instance involved the former president of the executive committee, Dominique Ollivier, who justified a \$347 oyster dinner in Paris as part of this fund.

Stricter rules on meal and alcohol expenses

The city is also clamping down on expenditures for meals and meetings. No exceptions for alcohol reimbursement will be allowed, except during protocol activities. This decision follows revelations about the taxpayer-funded wine served during a meal for Mayor Valérie Plante and guests in Vienna. Moreover, any hospitality expenses exceeding \$100 will now require prior approval and cannot be charged immediately to the City's credit card.

Elimination of performance bonuses

Starting in 2024, Montreal's city executives

will no longer receive performance bonuses. The last of these bonuses will be paid in the spring of 2023, marking an end to an annual expense of around \$7.8 million. This move comes after the Plante administration faced criticism for awarding a double bonus to compensate for the year 2020.

Additionally, new executives will not receive a car allowance, and existing allowances will be reviewed for relevance.

Ongoing review and savings

These reforms are part of a broader review aimed at refining spending directives. While the potential savings are not quantified, these measures are seen as steps toward fiscal responsibility, especially after a 4.9% average increase in residential property taxes for Montrealers.

Mayor Plante emphasized the importance of responsible spending, stating, "We wanted to show how important Montreal taxpayers' money is and we want to spend it well."

The opposition party, Ensemble Montréal, welcomed the end of performance bonuses but pointed out contradictions in the mayor's earlier defense of the double bonus. Opposition leader Aref Salem urged the administration to clarify these inconsistencies. In summary, the City of Montreal is taking definitive steps to curb unnecessary spending and ensure fiscal responsibility in the wake of public scrutiny and budgetary challenges.



Quebec teachers' strike continues as salary negotiations crawl

A look at the proposed salary increases

In the borough of Parc-Extension in Montreal, the impact of the ongoing teachers' strike is particularly palpable. Teachers affiliated with the FAE (Federation Autonome de l'Enseignement) in Quebec, including those in Parc-Extension's schools, have been absent from their classrooms for nearly a month. This situation arises as negotiations with the Quebec government continue at a frustratingly slow pace. These teachers, are actively voicing their demands for improved working conditions on the streets. A critical concern is the current composition of classes, which in this borough, like many others, are brimming with students who face various challenges. This issue is especially significant in Parc-Extension, where the diverse student population often requires additional resources and support to thrive academically.

Meanwhile, the government has leaked snippets of information about the salary increases it is proposing for teachers. Here's a breakdown of what these proposed salary increases entail, in addition to the impact of increases already granted in 2021 to make the profession more attractive.

Annual Salary at Entry Level (Step 3) Governmental offer: \$60,684 Current salary: \$53.541

Before the last collective agreement: \$46,115

The current government proposal represents a 13.34% salary increase for teachers entering the job market. If accepted, the entry-level salary will have risen by 31.59% from 2019 to 2026.

Annual Salary After 13 Years (Step 17) Governmental Offer: \$104,282 Current Salary: \$92,027

Before the last collective agreement: \$82,585 The government's offer represents a 13.31% salary increase for teachers with 13 years of experience. If this proposal is accepted, the maximum salary for teachers will have seen an increase of 26.27% from 2019 to 2026.

For comparison, the average salary in Quebec was \$60,492 in 2023 and has increased by about 26% since 2019. During the same period, the minimum wage evolved by approximately 27%.

ICI Television throws a party to celebrate its first 10 years

Montreal's sole independent ethnic station serves 17 cultural communities

The entrepreneurial family behind one of Canada's most ambitious multicultural broadcast media ventures hosted a celebration for its many loyal clients and supporters in Montreal last week to mark the anniversary of its first decade of operation.

ICI Television, an independent multicultural station with its transmitter near downtown Montreal on top of Mount Royal, has seen its share of challenges over the past 10 years.

David vs. Goliath

But, as in the storied biblical tale of David and Goliath, ICI Television overcame initially great odds against a mighty foe, to gather a loval following of supporters and a comprehensive schedule of programming in 17 languages.

Although ICI Television has undergone

several transformations over the years, the station's most recent incarnation dates back to 2013. That's when Mohammad Norouzi, a Persian Montrealer, struck a deal with Rogers

Media to support ICI Television.

ICI first started airing programming in December 2013, taking on the role as Montreal's sole dedicated multicultural television broadcaster.

CBC's pre-emptive strike

However, not long before this, the aforementioned Goliath (a.k.a. CBC/Radio-Canada) came along. The federal government-owned national network claimed in a lawsuit, filed pre-emptively in March 2013, that ICI Television's branding violated a Radio-Canada claim to "Ici" as a registered trademark.

In spite of that, ICI Television has managed to survive and even flourish for 10 years in an increasingly turbulent mass media environment.

As for the CBC, they recently announced a hiring freeze, as well as plans to cut 600 jobs to help make up for an anticipated \$125-million shortfall. This in spite of the more than \$1 billion in funding CBC/Radio-Canada receives from the federal government annually.

The 'power of dreams'

"A decade ago, an ambition was realized when ICI Television was born," Sam Norouzi, Mohammad's son who is senior vice-president and general manager of ICI, told a gathering of several hundred guests at the Volare Plaza Hotel on Côte de Liesse Rd.

They celebrated with beverages from an open bar, before enjoying a lavish seafood buffet and a full-course meal.

Sam called the station's success "a testament to the power of dreams, hard work and the unwavering support of our viewers, partners and dedicated teams," while adding that "we have strived to provide quality content that entertains, informs and resonates with our

diverse audiences."

Video clip from Trudeau

Prime Minister Justin Trudeau, who normally might issue a written congratulatory statement on a PMO letterhead when acknowledging a significant milestone by a person or organization, sent a videotaped message several minutes long, suggesting the high regard he has for ICI Television.

'To everyone celebrating this evening and to all of you who've worked so hard in the past 10 years, thank you – here is to many more years of success," said the Prime Minister.

In an interview with Newsfirst Multimedia, Sam Norouzi pointed out that of the many ownerships ICI Television has been through, the current one under the Norouzi family is the first to have lasted a full ten years. "So, it's quite a milestone, it's quite humbling, and it's a very exciting experience," he said.

Coping with the turbulence

As these are turbulent times for everyone with a stake in mainstream media, Sam acknowledged that ICI Television is not an exception to this trend – although it is managing to cope while maintaining a positive outlook towards the future.

With the phenomenon of cord-cutting and ad revenues transitioning to streaming services, that effect is compounded and multiplied for ethnic media, because we have to play the same game but with one hand tied behind our back," he said, noting they don't have access to big advertisers because of differences in how ICI's viewership gets rated.

"So, it is a difficult situation," Sam added. "Still, we've been able to survive so far through very responsible management. And, for that reason, we are very optimistic about the future."

For the last 32 years, when many women and children have been in crisis in the greater Montreal region, they turned to the Shield of Athena for help.

With that in mind, a cross-section of supporters from the community came together recently to raise \$150,000 to help fund Shield of Athena's biggest expansion to date: the Second Step Shelter, which is being built in Laval.

Family violence

The Shield of Athena is a non-profit organization for victims of family violence. It has three points of service in Montreal and Laval, as well as a community outreach department.

Their network offers emergency shelter and professional services to women and their children. Shield of Athena's multilingual support, intervention and prevention services are also adapted to meet the needs of many of the region's communities.

Thousands reached

As well, the Shield of Athena reaches thousands more through information sessions, publications, videos and media programs offered through their multilingual community outreach.

The Shield of Athena's Lilac Event, which was held at the Palace Convention Centre in mid-November, celebrated the work the Shield and its staff conduct on a daily basis.

As the need for the Shield's services has continued to grow, funds raised will ensure the completion of Laval's only Second Step shelter, while supporting the expansion of Athena's House, the Shield's emergency shelter.

The support they need

Set to open in 2024, the Second Step shelter

will have 17 apartments which will be able to house women and children for up to two years. During their time at the Second Step shelter, the women will receive the specialized support they need to emerge stronger and self-sufficient. "Our Second Step shelter will be able to house

"Our Second Step shelter will be able to house between 34 and 54 people at any given time," Melpa Kamateros, executive director of the Shield of Athena, told 200 supporters who turned out on Nov. 17 at The Palace congress centre in Laval for the Lilac Event.

"On behalf of our entire organization - and the people that their contributions will help to lift up - I cannot thank our community and our sponsors enough for their support."

Just the beginning...

"Our Lilac Event was an incredible success, and this evening is only the beginning of a concerted campaign to increase the support for women and children in crisis," added Chris Ann Nakis, president of the Shield of Athena board of directors.

"Currently, we provide services in 17 languages and to 1,100 women and children annually. Every penny raised is critical to continuing and expanding our work," she said.

"Our ultimate goal is to eradicate violence against women and children," said Carole Leblanc, president of Mercedes-Benz Laval, Godmother of the Second Step Resource, and a Silver level premium donor to the Lilac Event.

Ali Ngarukiye found guilty of attempted murder of Montreal police officer

In a significant development, Ali Ngarukiye has been found guilty by a Montreal jury on Wednesday of the attempted murder of a city police officer, along with several other charges stemming from a 2021 incident.

The 2021 Attack on Officer Sanjay Vig

The incident that led to Ngarukiye's conviction occurred in January 2021 in Parc-Extension. During a routine traffic stop on January 28, Ngarukiye attacked Officer Sanjay Vig. In a shocking turn of events, he managed to disarm the officer and fired his service weapon before fleeing the scene. This act of violence prompted an immediate and intensive investigation by Montreal police.

Wrongful Arrest of Mamadi III Fara Camara

The attack had far-reaching consequences, leading to the wrongful arrest of Mamadi III Fara Camara, who was present at the site of the attack. Camara faced charges of attempted murder and was detained for six days. However, he was released shortly after when further investigations cleared him of any involvement in the attack on Officer Vig.

The Capture of Ngarukiye

Ngarukiye's apprehension came nearly two months after the attack, on March 25, in Toronto. He was already known to the authorities there due to a history of fraud charges. A breakthrough in the case came when DNA traces found at the Montreal crime scene led investigators directly to Ngarukiye. This evidence played a crucial role in his trial and subsequent conviction.

Charges and Conviction

Ali Ngarukiye faced several serious charges, including attempted murder, aggravated assault, disarming a police officer, discharging a firearm, and carjacking. The jury, after hearing all the evidence, found him guilty of all charges.

A Second Trial Awaits

In a further twist, Ngarukiye is also facing charges in a separate case. He is accused of second-degree murder in the death of his cellmate, André Lapierre, at the Rivière-des-Prairies detention center in June 2021. This case adds another layer of complexity to Ngarukiye's legal troubles and highlights the ongoing challenges within the criminal justice system.

The conviction of Ali Ngarukiye marks a significant moment for Montreal's law enforcement, reflecting the city's commitment to bringing perpetrators of violent crimes to justice. However, the incident also raises questions about police procedures and the swift administration of justice, especially in light of the

wrongful arrest of Mamadi III Fara Camara. As the city moves forward, these issues will likely continue to be a topic of public and legal discourse.



Details of the Federal Dental Care Plan for Seniors

The federal dental care program, already available to children under the age of 18, will be phased in to Quebecers and low-income Canadians over the age of 65, the Trudeau government announced Monday.

Invoices related to Sun Life dental insurance will be partially or fully reimbursed by federal funds based on the applicants' income.

Letters will be sent to those who are eligible. "Seniors who receive an invitation letter will be able to call Service Canada to apply for membership and will only have to answer a few questions," Public Services and Procurement Minister Jean-Yves Duclos said Monday.

An online application portal is also planned by May.

Applicants must not already have dental insurance and be Canadian residents.

Dental Services Covered

• Preventive services, including descaling (cleaning), polishing, sealants and fluoride

• Diagnostic services, including examinations and x-rays

- Restoration services, including fillings
- Endodontic services, including root canals
- Prosthodontic services, including removable full and partial dentures
- Periodontal services, including deep scaling
- Oral surgery services, including extractions

Total repaid based on adjusted family net income

- \$70,000 or less: 100%
- Between \$70,000 and \$80,000: 60%
- Between \$80,000 and \$90,000: 40%

Dates from which applications will be accepted

- Seniors aged 87 and older: December 2023
 - Aged 77 to 86: January 2024
 - Aged 72 to 76: February 2024
 - Aged 70 to 71: March 2024
 - Aged 65 to 69: May 2024

Dentists and their patients still have questions about the Canadian Dental Care Plan

After the announcement that eligible seniors will be invited to apply for enrollment in the Canadian Dental Care Plan (CDCP) starting this month, and care could begin as early as May 2024, many questions remain. It is unclear how this new program will affect patients and dentists across the country. The CDCP will only succeed if the federal government taps into the expertise of practising dentists, through their provincial and territorial dental associations, right at the start.

The CDCP is intended to help millions of people without dental benefits access essential oral health care. Although this is an historic investment, the CDCP has been developed under tight timelines and with limited involvement of practising dentists. It is critical that the government has a full understanding of the impact it will have on patients trying to access the program.

Despite an announcement about the start of patient enrollment, Canadians still don't know:

- Will I be allowed to choose my own dentist?
- Will the plan replace my current work, school and/or group dental benefits?
- What will happen to any other public dental programs that I am already eligible for?
- Will the plan be easy to use or will there be needless administrative hurdles and red tape?

• What will I have to pay for my dental care? Patients are already asking their dentists these questions, but the answers they need from the federal government aren't yet clear.

Since the first federal announcement almost two years ago, dental associations have clearly said they know how to build a plan that will work for patients, dentists, and taxpayers. As experts in oral healthcare delivery, dentists across Canada prepared their advice to the federal government in <u>A Proposed Framework</u> for the Canadian Dental Care Plan, which was shared publicly in November. The comprehensive and actionable framework is based on decades of data, research and expert input from practising dentists across regions and specialties. It outlines ways in which the CDCP could be successfully implemented.

While some of the information was considered by Health Canada, the dental associations see some important concerns and gaps that need to be filled. Recently, the dental associations met with Health Canada to outline this framework and their remaining questions. Today's announcement reveals that there is still more to discuss and much more work to be done before the plan can launch.

In the meantime, to address some of the immediate concerns surrounding the CDCP, the provincial and territorial dental associations:

- Remind patients not to delay treatments or dental appointments. Regular checkups now can help catch problems before they become painful and expensive to treat.
- Strongly encourage employers and other groups to keep the dental benefits for their employees and members, so they don't lose access to care.
- Urge the government to implement a coordinated plan to increase skilled labour for dental offices. Without it, patients could face delays in getting the dental care they need.

Dental associations look forward to working with federal government officials to help them with their implementation plans for the CDCP. Dentists want to help make great access to care a reality for everyone.




